Hoag Endowed Chairs

SUPPORTING EXTRAORDINARY LEADERS

Hoag's commitment to innovation has led it to adopt the endowed chair model, common in academia but rare in a community health care setting. Endowed Chairs are a hallmark of great institutions and are one of the most prestigious honors that can be bestowed on a physician. The benefits of endowed chairs are exponential. They enhance the reputation of the organization as a whole which serves to attract other renowned clinicians and staff. They provide an important source of sustainable funding for physician leaders to advance their specialties and they inspire potential supporters who are moved by what they represent.

Funding Endowed Chairs

Establishing and naming a new endowed chair starts at \$1.5 million and, depending on the type of chair, can go up to \$5 million or more. Donors can fund endowed chairs using a variety of vehicles including a combination of planned gifts and outright gifts.

Endowed Chair Selection Process

At Hoag, our physician leaders are tasked with program development, implementation and growth. They create programs that elevate care for all patients, not just the ones in their own private clinical practices. Endowed chairs may be established for Hoag program directors, medical directors or executive medical directors.

Endowed Chair Holder Use of Funds

Endowed chairs provide sustainable resources for chair holders to advance care in their areas of specialty. The physician "holds" the chair and, through wise stewardship, maximize it until it's time to pass it on to the next recipient. Endowed chair holders have a wide degree of discretion and funds are used for a variety of purposes such as building or enhancing programs that benefit the entire population through support programs, research, new technology and recruiting expert staff.

Each endowed chair holder creates a three-year plan for how he or she intends to utilize the funds. They review the plans with their Hoag executive sponsor who ensures the plans are aligned with Hoag's strategic direction.

The Hoag Hospital Foundation Endowed Chair counsel supports endowed chair holders in ensuring the funds are used as endowed chair donors have intended.

Current Hoag Hospital Foundation Endowed Chair Holders

Hoag now has a total of 13 endowed chairs in a variety of areas including cancer, heart and vascular, neurosciences and diabetes. Each endowed chair holder, and the donors who support them, are recognized and honored in formal Investiture ceremonies.
